MINUTES OF THE CYFFYLLIOG COMMUNITY COUNCIL MEETING HELD ON THURSDAY 9TH JANUARY 2025 VIA ZOOM CONFERENCE AT 7.00 P.M.

1: PRESENT:

2. APOLOGIES FOR ABSENCE.

Councillors Emrys Williams, Eifion Jones, Elwyn Jones, Gethin Jones and Huw Jones.

<u>3. DECLARATIONS OF INTEREST ON ANY AGENDA ITEM LISTED BELOW.</u> None received.

<u>4. DISCUSSION WITH THE MEMBERS OF THE PUBLIC IN ATTENDANCE.</u> None in attendance.

5. CONFIRM THE MINUTES OF THE PREVIOUS COUNCIL MEETINGS. Members confirmed 14th November and 10th December 2024 minutes as a true record.

6. MATTERS ARISING FROM THE MINUTES NOT APPEARING ON THE AGENDA.

A: Members confirmed that A.W. Lloyd Forestry and Gardening Services was awarded the contract to remove the fallen trees within the Cyffylliog Church Cemetery on the basis he could remove the trees immediately. The fallen trees were removed within two days B. The Chair reported that the fly tipping continues at the Bontuchel bus shelter lay-by. A local resident suggested that the Community Council provides CCTV cameras onsite. Members resolved that the provision of CCTV cameras onsite would be too expensive and would have legal issues obstacles to overcome.

7. DISCUSSION WITH THE YOUTH COUNCIL MEMBER IN ATTENDANCE. Nothing to update.

8. FORMER CYFFYLLIOG SCHOOL UPDATED REPORT.

Councillor Aled Rees reported that the Clocaenog Wind Farm Fund for £10,000.00 grant aid funding towards the costs of the Architects Fees which is the next stage of the former Cyffylliog School process has been successful.

9. CYFFYLLIOG CEMETERIES MAINTENANCE UPDATE.

Members discussed the potential of removing the remaining sections of the two trees that are still rooted into the ground but are considered a health and safety issue. The Chair agreed to contact Mr Nathan Hunt, Tree surgeon, for advice if the tree remains should be removed and require a "Tree Preservation Order" application for removal.

10. CYFFYLLIOG CEMETERIES WASTE BINS.

Denbighshire County Council provided quotation of £937.50 for the provision of two waste bins (including accessories) and £280.00 installation charge for the proposed Cyffylliog Cemetery waste bins. Members resolved, in the first instance, to apply for the Denbighshire County Council Commuted sums fund which has £1,266.69 allocation for the Cyffylliog area.

11. COUNCIL'S INFORMATION TECHNOLOGY AND ASSOCIATED EQUIPMENT.

The Clerk now has received a new "Community Laptop" provided by another Community Council. The laptop can be used for Cyffylliog Community Council remote access meetings if required.
